DATE: June 17, 2024 – Palma 4-Man Team Match or Squadded Individual Practice (concurrently)(starts 8:00 am)
June 18, 2024– Palma® Individual Match (entries close 7:30 am)(starts 8:00 am); 1200 yd Match (pm)
June 19, 2024 – Palma® Individual Match (entries close 7:30 am)(starts 8:00 am); 2-Man Team 900 yd (pm)
June 20, 20234– Palma® Individual Match (entries close 7:30 am)(starts 8:00 am); 2-Man Team 1000 yd (pm)
June 21, 2024 – Three 1,000 yd Individual Matches (entries close 7:30 am)(starts 8:00 am)

LOCATION: Winnequah Gun Club is approximately three miles north of Lodi, WI. Take I-90/94 West to Exit 115; turn right onto County Road CS (0.2 mile); turn left at County Road J (1.1 mile); turn right at County Road J at the T in the road (3.3 miles). Look for Winnequah Gun Club sign and Indoor Range on your left. Go through the gate and past the building. Follow the road to the High Power Rifle Stat Office. The club address is: W10219 Larson Dr., Lodi WI 53555. More information is on the club web site. Camping is permitted; the gate will be open by mid-afternoon on Friday, June 14.

RULES: Current NRA High Power Rifle Long Range and F Class Long Range Classification rules will apply. Empty chamber indicators (Rule 3.21) will be available at the range and **MUST** be used by all competitors.

SAFETY: If a competitor fails to get on target in **FIVE SHOTS** he/she will be directed to stop firing. Bolts cannot be closed until the rifle is shouldered and pointed towards the target.

ELIGIBILITY: Open to all competitors, membership in the NRA is not required. Competitors must be an NRA member to set a NRA National Record. Teams will consist of four firing members, a captain and/or coach. The team captain and/or coach may be firing members of the team. A team captain **MUST** be named (Rule 12.1). Team representation Club-Rule 2.11; Law Enforcement Agency-Rule 2.12; a Regular Service Unit or a Reserve Unit (including National Guard)-Rule 2.13; State Association-Rule 2.12; or Junior-Rule 2.18.

EQUIPMENT:

Individual Matches: Palma® Match – Palma® Rifle or Match Rifle, chambered for the unmodified .308, sights metallic only Rule 3.7(a)(1), and 3.7(a)(2)
Individual Matches: Service Rifle – Rule 3.1,3.1.1,3.1.2,3.1.3 (includes .223 Rem)
1,000 yd Matches: Any safe Centerfire Rifle or Service Rifle. Muzzle brakes not allowed. Any safe ammunition. Match 6, IRON SIGHTS must meet NRA Rule 3.7(a)(1) noncorrective or Rule 3.7(a)(2) corrective requirements. Match 7 ANY SIGHTS, Rule 3.7(a).
1,000 yd Matches: Palma® Rifle – Any Sight; Any Rifle Iron Sight
1,000 yd Matches: Any Rifle – Rule 3.2, Any Sight-Rule 3.7(c)
2-Man Team Matches: Palma® Rifle Iron Sights; Any Rifle Any Sights; F Class Open or FTR
Palma® 4-Man Team: Palma® Rifle – Rule 3.3.3, metallic sight, Rule 3.7(a)
F Class: Rule 3.4 in NRA High Power Rifle Rules, Section 22
1200 yd Match: No rifles smaller than 6mm, 100 grain bullet. **OPTICAL SIGHTS ONLY!**

Ammo must be Supersonic at the 1200 yard line (1126 fps).

ENTRIES: Individual entries will be made by using the enclosed entry form accompanied by a check or money order. Be sure to indicate your correct NRA Long Range Prone or F Class Prone classification. Unclassified competitors will compete in the Master Class. Rule 19.6 Assigned Classification or 19.2 Temporary Classification may be used in making entry. **IF YOU ARE NOT CHECKED IN AT THE STAT OFFICE 30 MINUTES BEFORE FIRING TIME, YOUR SPOT WILL BE GIVEN TO A PERSON ON THE WAITING LIST.** Mail individual entry form with correct fees to:

Long Range targets will be used at 800,900,1000 yd
F Class targets will be used at 800,900,1000 yd – LR-FC

SQUADDING: All matches will be squadded. Individual packets will be available for pick up at the Stat Office on Sunday, June 16. Competitors must report to the Stat Office before firing each day. **If your NRA Long Range and F Class prone classification has changed, please show your new card before squadding is issued.** Unclassified competitors will compete in the Master Class. Rule 19.6-Assigned Classification, or 19.2-Temporary Classification, may be used in making entry. A competitor who fails to present himself/herself at the proper firing point when his/her relay is called may lose their right to compete in that event. Competitors must stay on their own relay before firing. Squadding for the Team Match will be given at the Stat Office when registration is completed.

COURSE OF FIRE: Silver Mountain Electronic Target System will be used for scoring. Competitors will be required to score/verify. Please bring a spotting scope or binoculars for verifying all shots fired on the target. Failure to do score/verifying duties may result in a EQ.

- Match 6: 1,000 yd Individual, 20 shots, Any Rifle, Iron Sight, unlimited sighters, 30 minutes
- Match 7: 1,000 yd Individual, 20 shots, Any Rifle, Any Sight, unlimited sighters, 30 minutes
- Match 8: Palma® Aggregate (Matches 2,3,4)
- Match 9: 1,000 yd Aggregate (Matches 5,6,7)
- Match 10: Midwest Palma®/F Class Championship Aggregate (Matches 8,9)

A SHOOT-OFF - will be held this year after Match 10 has been completed. The top 10% or a minimum of three competitors will qualify for the shoot-off. The combined scores of Match 10 and the Shoot-off will determine the winner of the Midwest Palma Championship.

Course of Fire:

- 3 sighters, 15 shots for record, 18 minutes – sling shooters; Palma Rifle must be used in shootoff
- 3 sighters, 15 shots for record, 18 minutes – F Class Open
- 3 sighters, 15 shots for record, 18 minutes – F Class FTR

A SPECIAL AWARD will be given to those competitors who use a Palma® Rifle with metallic sights for Matches 2,3,4,5,6,7

AWARDS: 50% of the individual entry fees will be returned to the competitors in cash awards. Awards will be given if there are 5, 10, 15 or more competitors in a given match or class. If there are less than five individuals or three teams in a class, they will be combined with the next class, except for High Masters. Lower classes will not be combined with the High Master class. The Liebetrau Sighting Shot Aggregate will be for the 900 and 1,000 yd stages of each Palma® Individual Match (Tuesday, Wednesday, Thursday). Awards for 2-Man Team Matches will be given if three or more teams compete in the Palma® Rifle and Any Rifle categories.

F CLASS COMPETITORS: All individual events are open to participation by F Class competitors. Awards in F Class will be made based upon the number of F Class competitors in the match. A cash prize will be awarded at the Awards Banquet for the highest F Class competitor, provided there are five (5) or more F Class competitors entered in Open and FTR. If there are three (3) or more F Class teams entered in the 4-Man Team match, an award will be given.

1200 YD MATCH – range capacity is 128 people. Please indicate on the entry form if you plan to compete in this match. Pay entry fees at the Stat Office before going to the firing line. Appropriate awards will be given.

2-Man Team – this will be an extra match after completion of the Palma® Individual matches on Wednesday and Thursday for anyone who wishes to enter. A \$15.00 entry fee will be collected from each person and distributed among the winners. The entry card and fees must be turned in at the Stat Office before going to the firing line. This match will be squadded at the Stat Office. Each two man team assembles on the 900 yd line (Wed) and the 1000 yd line (Thurs). Rifles to be used are: Palma® Rifle Iron Sights, Any Rifle Any Sights, F Class Open or FTR.
